

## The Federated Church Endowment Funds as of June 12, 2007

The Endowment Fund of Federated Church of West Lafayette, Indiana is composed of several specific endowments (\*) with restrictions regarding their use. They are:

- **AMY L. BRINGHAM FUND for Special Missionary Projects.** The income from this fund is to be used for special missionary offerings/gifts as distinguished from the regularly-budgeted missionary funds of Federated Church. (Estab. Before December 31, 1984)
- **NORMAN L. GODBEY FUND for Senior Citizen and Homebound Ministry.** The income from this fund is to be used for special needs of senior citizens and other Christian homebound persons. (Estab. Before September 30, 1991)
- **JEFF GUNKEL FUND for Scholarship Assistance to Youth.** The income from this fund is to be used to provide scholarship assistance to male youth of Federated Church who attend conferences at the American Baptist Assembly, Green Lake, Wisconsin. (Estab. November 20, 1985; purposes amended by the Federated Endowment Fund Board, February, 1994).
- **MARK MOHLER MEMORIAL FUND for Youth Education and Leadership.** The income from this fund is to be used for training of youth for leadership, and for adult training for work with youth of Federated Church. (Estab. Before August, 1984)
- **DOYLE MULLEN MEMORIAL FUND for Christian Theological Seminary Education.** The income from this fund is to be used for a young person interested in seminary training at the Christian Theological Seminary (CTS) in Indianapolis, Indiana (Estab. May 25, 1984)
- **JEANETTE W. & WERNER L. NELSON FUND for Seminary Students and Campus Evangelism.** The income from the fund is to be used for education of seminary students and/or campus evangelism such as Crusade for Christ, Intervarsity, or Navigators. (Estab. Dec. 27, 1986)
- **MILDRED R. TAYLOR FUND for Scholarships for Youth.** The income from this fund is to be used to provide scholarships to youth of Federated Church for conferences at Green Lake Baptist Assembly, or other youth conferences of similar purposes. (Estab. Dec. 6, 1993)
- **FRANCIS W. TRIMMER MEMORIAL FUND for Christian Vocation and Education.** The income from this fund is to be used as an educational scholarship for a young person from the congregation of Federated Church who is preparing for a Christian vocation. (Estab. Before May 1984)
- **CURT M. WILSON FUND for Youth Education Programs & Projects.** The income from this fund is to be used for special educational programs and youth endeavors as directed by the Minister of Christian Education & Youth. Also, up to 5% of the capital appreciation may also be distributed provided the fair market value of the fund does not fall below \$15,000. (Estab. May 30, 2000)
